

## **APPRENTICE SCHOLARSHIP INFORMATION**



## When applying for apprenticeship scholarship you require:

- 1. Signed Promissory Note
- 2. School Receipt (tuition fee)
- 3. Letter from Alberta Learning with your marks period (both sides)
- 4. Blue Book **Stamped** by the Apprenticeship Board
- 5. <u>Must</u> complete a minimum of 16 hours from **EPT's Course Calendar**. EPT <u>will not</u> accept safety courses for the **mandatory** course for tuition. There will be two exceptions First Aid and LSE but must be taken in the year you go to school.
- 6. Must have 1200 Local Union 488 Contractor Contributed hours.
- 7. Must be a Member in good standing
- 8. If you are a Journeyman, please bring your Journeyman letter from Alberta Learning or your Journeyman Certificates. You will also be required to submit your UA Card so that we can send it to head office.
- 9. Apprentice scholarship may only be received within 2 years of completion of trade school dates.
