## **UA Local 488 Apprentice Scholarship**

UA Local 488 apprentices may be eligible for an Apprentice Scholarship when he/she completes a level of their apprenticeship program. Apprentices may apply for their scholarship money with the Education Department after completing their level of apprenticeship program. The requirements an apprentice must meet to qualify for the scholarship are:

- Must be a member in good standing at the time of attending Apprenticeship school or challenging the period exam.
- 2. Blue Book Stamped by the Apprenticeship Board OR AIT ID Card
- 3. Letter from Alberta Learning with your period marks
- 4. School Receipt (Tuition Fee)
- 5. Signed Promissory Note

- 6. Must have 1200 Local Union 488 Contractor Contributed hours.
- If you are Journeyman, please bring your Journeyman letter from Alberta Learning or your Journeyman certificates. You will also be required to submit your UA Card so that we can send it to head office.
- 8. Apprentice scholarship may only be received within 2 years of completion of trade school dates.

Shortly after returning from Michigan, I passed my C-pressure, and then my B-pressure and subsequently, GMAW, SAW, GTAW, orbital GTAW, and SMAW downhand tickets. Most recently, I have attained my ABSA Weld Examiners certification..

Since joining Alberta Pipe Trades College in 2012, I have had the privilege of

teaching all levels of apprenticeship, CWB courses, Journeyperson to B-Pressure courses, Tradewinds, and Introduction to Welding courses. I also help at our weld test centre as an ABSA Weld Examiner.

## EPRI Industrial Rigging and Crane Signaling Certification

For over two decades journeyperson members with rigging experience have had the opportunity to obtain the EPRI Industrial Rigging and Crane Signaling Certification at the UA Local 488 training facilities. This certification is obtained from the UA Head Office and is recognized across North America by clients and contractors in Industry as the premier rigging certification in the marketplace. This certification has proven valuable for UA members performing rigging tasks safely and efficiently for our clients and contractors

### **Course Facts**

Tuition: \$60.00 – eligible for reimbursement upon successful completion

Required Books: Extra Cost that is not eligible for reimbursement

Pre-Requisite: UA Journeyperson member in good standing

The EPRI Industrial Rigging and Crane Signaling Certification program is 40 hours and offered Monday to Friday for one week.

Students perform Industrial Rigging and Crane Signaling 120 question written exam with a passing score of 80% or better

Students perform Industrial Rigging and Crane Signaling Performance exam of 3 skill set lifts

Upon successful completion of both examinations, UA member has an EPRI Industrial Rigging and Crane Signalling certification and a Signal Person Certification, both are valid for 5 years.

UA Member is required to recertify their Industrial Rigging and Crane Signaling certification before their 5-year expiration date. UA Members are required to attend a minimum 4-hour review class and pass a 120-question written examination only with an 80% or better. No performance exam is required for recertification.

## Sprinkler Systems Installer Training

The National Sprinkler Industry JTAC is pleased to announce the online member learning management system (LMS) portal available to all current sprinkler journeypersons and apprentices under the National Road Sprinkler Fitter Collective Agreement at no cost to the UA Member.

This LMS will provide enhanced learning opportunities to the membership as well as provide a continual resource to the content from your personal computers and devices. This platform is not intended to replace in person training and critical hands-on experience currently part of upgrade training provided for this trade through your local training centres. This LMS will allow for a complementary learning experience and provide distance and remote training opportunities at a self pace format along with additional instructor lead options that were previously not available to the membership.

Currently, there are courses available for member enrollment on the site with upcoming content to be continually added as it is developed. Your log in will land on your personal dashboard and allow access to the course catalogue, courses you have in progress and course results/ certificates. We will continue to add course/materials along with manufacture-based training and certifications as they become available. Username and password for the NFPA all access will be maintained under the resource tab. Please go to www.nationalsprinklerjtac.org to access the LMS portal.

Your username to login is your full name as it appears on your UA Card without spaces (do include any apostrophes and dashes where present) followed by underscore and your local number. For example: Taylor J Smith of Local 853 would have a username of taylorjsmith\_853 (your password is your UA Card number).

The site will correspond through the current emails provided to UA head office. Be sure to check your profile settings when you log in and forward any corrections or changes to your email through your local training department.

## Welder Performance Qualification Test

Welders in the pipe trade industry must have a basic understanding of many things, one of which is their welding Performance Qualification Card and the variables that apply. The illustration provides a more in depth look at the meaning of the information found on a PQ card.

"F" Numbers are assigned based on their usability characteristics which determines the ability of the welder to make satisfactory welds with a given filler metal

"P" Numbers are assigned based on comparable base metal characteristics such as composition, weldability and mechanical properties

Pressure Welders Regulation (Alberta Regulation 169/2002) - Prohibitions 2(1) No person shall weld a boiler, pressure vessel, pressure piping system or fitting by any method unless the person holds a certificate of competency, including a performance qualification card, that specifically authorizes the person to weld the pressure vessel, boiler, pressure piping system or fitting

## **AWWA Cross Connection Control Tester Certification**

Certified by American Water Works Association (AWWA) www.wcsawwa.net, Cross Connection is commonly referred to as Backflow Prevention. Every facility contains multiple points of potentially potable water contamination. This course identifies those areas and provides the code interpretation and knowledge base required of Cross Connection Control Specialists.

You will learn how to determine the proper cross connection prevention device for an application, test the device and demonstrate the skill required to ensure public safety. Upon successful completion of this course and the AWWA examination, the student will qualify as a Cross Connection Control Tester.

**Required Books:** Extra Cost that is not eligible for reimbursement

The AWWA Cross Connection Control Tester Certification program is 40 hours and offered Monday to Friday for one week.

Students perform AWWA Cross Connection Tester 100 question written exam with a passing score of 75% or better.

Students perform AWWA Cross Connection Tester performance exam on 3 backflow devices. Upon successful completion of both examinations, UA member has an AWWA Cross Connection Control Tester certification that is valid for 5 years.

UA Member is required to recertify their AWWA Cross Connection Tester certification before their 5-year expiration date. UA Members are required to attend a minimum 4-hour review class and pass a 50-question written examination only with an 75% or better. No performance exam is required for recertification.
