

UA Local 488 apprentices may be eligible for an Apprentice Scholarship when they complete a level of their apprenticeship program. Apprentices may apply for their scholarship money with the Education Department after completing their level of apprenticeship program. The requirements an apprentice must meet to qualify for the scholarship are as follows:

### When applying for apprenticeship scholarship you require:

1. Signed Promissory Note
2. School Receipt (tuition fee)
3. Completion letter from Alberta Learning
4. Marks from AIT account for the school period (Full view)
5. Blue Book **Stamped** by the Apprenticeship Board **OR** Updated AIT ID Card
6. **Must** have 1200 Local Union 488 Contractor Contributed hours.
7. **Must** be a Member in good standing
8. If you are a Journeyman, please bring your Journeyman letter from Alberta Learning or your Journeyman Certificates. You will also be required to submit your UA Card to Local 488, so that they can send it to head office.
9. Apprentice scholarship may only be received within 2 years of completion of trade school dates.

### When challenging exam for school period, you require:

- a. Application Form
- b. Receipt
- c. Alberta Learning Letter of passing exam
- d. AIT ID card or Stamped Blue Book of updated status
